- 4 SECTION 1. Section 134.001, Education Code, is amended by 5 adding Subdivision (1) to read as follows:

- 6 (1) "Commission" means the Texas Workforce
- 7 Commission.
- 8 SECTION 2. Section 134.002(a), Education Code, is amended
- 9 to read as follows:
- 10 (a) The <u>commission</u> [<del>comptroller</del>] shall establish and
- 11 administer the Jobs and Education for Texans (JET) fund as a
- 12 dedicated account in the general revenue fund.
- SECTION 3. Section 134.003, Education Code, is amended to
- 14 read as follows:
- Sec. 134.003. ADVISORY BOARD. (a) An advisory board of
- 16 education and workforce stakeholders is created to assist the
- 17 commission [comptroller] in administering this chapter.
- 18 (b) The advisory board is composed of  $\underline{\text{six}}$  [seven] members
- 19 who serve two-year terms and are appointed as follows:
- 20 (1) one member appointed by the governor;
- 21 (2) one member appointed by the lieutenant governor;
- 22 (3) one member appointed by the speaker of the house of
- 23 representatives;
- 24 (4) one member appointed by the Texas Higher Education

- 1 Coordinating Board;
- 2 (5) one member appointed by the commission [Texas
- 3 Workforce Commission]; and
- 4 (6) the chair of the commission [one member of the
- 5 public appointed by the comptroller; and
- 6 [<del>(7) the comptroller</del>], who serves as the presiding
- 7 officer.
- 8 (c) The advisory board shall meet at least once each
- 9 quarter, or as needed, to review received applications and
- 10 recommend awarding grants under this chapter.
- 11 SECTION 4. Section 134.004, Education Code, is amended to
- 12 read as follows:
- 13 Sec. 134.004. JOBS AND EDUCATION FOR TEXANS (JET) GRANT
- 14 PROGRAM. (a) The commission [comptroller] shall establish and
- 15 administer the Jobs and Education for Texans (JET) Grant Program to
- 16 provide grants to public junior colleges, [and] public technical
- 17 institutes, and independent school districts described under
- 18 Section 134.007 that apply to the advisory board in the manner
- 19 prescribed by the advisory board. The <a href="commission">commission</a> [comptroller]
- 20 shall award the grants on the advice and recommendations of the
- 21 advisory board.
- (b) Grants may be awarded under this chapter from the Jobs
- 23 and Education for Texans (JET) fund to defray the start-up costs
- 24 associated with the development of new career and technical
- 25 education programs at public junior colleges, [and] public
- 26 technical institutes, and independent school districts described
- 27 under Section 134.007 that meet the requirements of Section

- 2 SECTION 5. Sections 134.006(a), (c), and (d), Education
- 3 Code, are amended to read as follows:
- 4 (a) The commission [comptroller] may award a grant for the
- 5 development of new career and technical education courses or
- 6 programs at public junior colleges, [and] public technical
- 7 institutes, and independent school districts.
- 8 (c) In awarding a grant under this section, the <u>commission</u>
- 9 [comptroller] shall primarily consider the potential economic
- 10 returns to the state from the development of the career and
- 11 technical education course or program. The commission
- 12 [comptroller] may also consider whether the course or program:
- 13 (1) is part of a new, emerging industry or high-demand
- 14 occupation;
- 15 (2) offers new or expanded dual credit career and
- 16 technical educational opportunities in public high schools; or
- 17 (3) is provided in cooperation with other public
- 18 junior colleges or public technical institutes across existing
- 19 service areas.
- 20 (d) To be eligible to receive a grant under this section, a
- 21 public junior college, [or] public technical institute, or
- 22 independent school district described under Section 134.007 must
- 23 provide matching funds in accordance with rules adopted under
- 24 Section 134.008. The matching funds may be obtained from any source
- 25 available to the <u>public</u> junior college, <u>public</u> [or] technical
- 26 institute, or independent school district, including [in-kind
- 27 contributions, industry consortia, community or foundation

- 1 grants, individual contributions, and local governmental agency
- 2 operating funds.
- 3 SECTION 6. Chapter 134, Education Code, is amended by
- 4 adding Section 134.007 to read as follows:
- 5 Sec. 134.007. GRANTS AWARDED TO INDEPENDENT SCHOOL
- 6 DISTRICT. The commission may award a grant to an independent school
- 7 district under this chapter if the district has entered into a
- 8 partnership with a public junior college or public technical
- 9 institute for the purpose of:
- 10 (1) promoting career and technical education to the
- 11 district's students; or
- 12 (2) offering dual credit courses to the district's
- 13 students.
- 14 SECTION 7. Section 134.008, Education Code, is amended to
- 15 read as follows:
- Sec. 134.008. RULES. The commission [comptroller] shall
- 17 adopt rules as necessary for the administration of this chapter.
- SECTION 8. (a) Not later than September 1, 2015:
- 19 (1) the administration of the Jobs and Education for
- 20 Texans Grant Program shall be transferred from the comptroller to
- 21 the Texas Workforce Commission;
- 22 (2) all rules, forms, policies, procedures, or
- 23 decisions of the comptroller that are related to the Jobs and
- 24 Education for Texans Grant Program are continued in effect as
- 25 rules, forms, policies, procedures, or decisions of the Texas
- 26 Workforce Commission until superseded by a rule or other
- 27 appropriate act of the Texas Workforce Commission;

- 1 (3) all money, obligations, memoranda of
- 2 understanding, leases, rights, and contracts, including grant
- 3 agreements, of the comptroller related to the Jobs and Education
- 4 for Texans Grant Program are transferred to the Texas Workforce
- 5 Commission, and the Texas Workforce Commission assumes, without a
- 6 change in status, the position of the comptroller in all
- 7 transferred contracts, including grant agreements, related to the
- 8 Jobs and Education for Texans Grant Program;
- 9 (4) records in the custody of the comptroller related
- 10 to the Jobs and Education for Texans Grant Program are transferred
- 11 to and become the property of the Texas Workforce Commission; and
- 12 (5) a reference in law or administrative rule to the
- 13 comptroller relating to the administration of the Jobs and
- 14 Education for Texans Grant Program means the Texas Workforce
- 15 Commission.
- 16 (b) Before the transfer of the administration of the Jobs
- 17 and Education for Texans Grant Program, the comptroller and the
- 18 Texas Workforce Commission shall coordinate the transfer of powers
- 19 and duties, including records, appropriations, disbursements,
- 20 compliance audits, monitoring and enforcement, and other items, to
- 21 ensure a smooth transition.
- SECTION 9. An independent school district may be awarded a
- 23 grant in accordance with Section 134.007, Education Code, as added
- 24 by this Act, beginning with the 2016-2017 academic year.
- 25 SECTION 10. This Act takes effect immediately if it
- 26 receives a vote of two-thirds of all the members elected to each
- 27 house, as provided by Section 39, Article III, Texas Constitution.
