other right of the estate as is determined to exist transferred to
the distributee as an heir or assignee.

3 (b) A list of all known estate assets under Subsection 4 (a)(3)(A) must indicate which assets the applicant claims are 5 exempt.

6 SECTION 2. Chapter 205, Estates Code, is amended by adding 7 Section 205.009 to read as follows:

8 <u>Sec. 205.009. CONSTRUCTION OF CERTAIN REFERENCES. A</u> 9 <u>reference in this chapter to "homestead" or "exempt property" means</u> 10 <u>only a homestead or other exempt property that would be eligible to</u> 11 <u>be set aside under Section 353.051 if the decedent's estate was</u> 12 <u>being administered.</u>

13 SECTION 3. Section 205.009, Estates Code, as added by this 14 Act, applies to the estate of a decedent that is pending on or after 15 the effective date of this Act, regardless of the decedent's date of 16 death.
