years have not elapsed since the date of the decedent's death and
 before the application;

3 (3) the court has jurisdiction and venue over the 4 estate;

5 (4) citation has been served and returned in the 6 manner and for the period required by this title; and

7 (5) the person for whom letters testamentary or of 8 administration are sought is entitled by law to the letters and is 9 not disqualified.

10 SECTION 3. Section 306.002(c), Estates Code, is amended to 11 read as follows:

12 (c) The court may find other instances of necessity for an 13 administration based on proof before the court, but a necessity is 14 considered to exist if:

there are two or more debts against the estate;

16 (2) there is a desire for the county court to partition 17 the estate among the distributees; [or]

18 (3) the administration is necessary to receive or
19 recover funds or other property due the estate; or

20 <u>(4) the administration is necessary to prevent real</u> 21 property in a decedent's estate from becoming a danger to the 22 health, safety, or welfare of the general public.

SECTION 4. The changes in law made by this Act apply only to an application for the grant of letters testamentary or of administration of a decedent's estate filed on or after the effective date of this Act. An application for the grant of letters testamentary or of administration of a decedent's estate filed
