5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. The following sums of money are appropriated out

- 12 SECTION 7. (a) Before any claim or judgment may be paid from
- 13 money appropriated by this Act, the claim or judgment must be
- 14 verified and substantiated by the administrator of the special fund
- 15 or account against which the claim or judgment is to be charged and
- 16 be approved by the attorney general and the comptroller of public
- 17 accounts. Any claim or judgment itemized in this Act that has not
- 18 been verified and substantiated by the administrator of the special
- 19 fund or account and approved by the attorney general and the
- 20 comptroller by August 31, 2017, may not be paid from money
- 21 appropriated by this Act.
- (b) Each claim or judgment paid from money appropriated by
- 23 this Act must contain such information as the comptroller of public
- 24 accounts requires but at a minimum must contain the specific reason
- 25 for the claim or judgment. If the claim is for a void warrant, the
- 26 claim must include a specific identification of the goods,
- 27 services, refunds, or other items for which the warrant was

- 1 originally issued. In addition, it must include a certification by
- 2 the original payee or the original payee's successors, heirs, or
- 3 assigns that the debt is still outstanding. If the claim or
- 4 judgment is for unpaid goods or services, it must be accompanied by
- 5 an invoice or other acceptable documentation of the unpaid account
- 6 and any other information that may be required by the comptroller.
- 7 SECTION 8. Subject to the conditions and restrictions in
- 8 this Act and provisions stated in the judgments, the comptroller of
- 9 public accounts is authorized and directed to issue one or more
- 10 warrants on the state treasury, as soon as possible following the
- 11 effective date of this Act, in favor of each of the individuals,
- 12 firms, or corporations named or claim numbers identified in this
- 13 Act, in an amount not to exceed the amount set opposite their
- 14 respective names or claim numbers and shall mail or deliver to each
- 15 of the individuals, firms, or corporations associated with each
- 16 claim one or more warrants in payment of all claims included in this
- 17 Act.
- 18 SECTION 9. This Act takes effect September 1, 2015.
