- 2 relating to permitted methods for certain political subdivisions to
- 3 post notice of a meeting.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Sections 551.053(a) and (c), Government Code,
- 6 are amended to read as follows:
- 7 (a) The governing body of a water district or other district
- 8 or political subdivision that extends into four or more counties
- 9 shall:
- 10 (1) post notice of each meeting at a place convenient
- 11 to the public in the administrative office of the district or
- 12 political subdivision;
- 13 (2) provide notice of each meeting to the secretary of
- 14 state; and
- 15 (3) either provide notice of each meeting to the
- 16 county clerk of the county in which the administrative office of the
- 17 district or political subdivision is located or post notice of each
- 18 meeting on the district's or political subdivision's Internet
- 19 <u>website</u>.
- 20 (c) A county clerk shall post <u>a</u> [the] notice provided to the
- 21 <u>clerk</u> under Subsection (a)(3) on a bulletin board at a place
- 22 convenient to the public in the county courthouse.
- SECTION 2. Section 551.054, Government Code, is amended to
- 24 read as follows:

- 1 Sec. 551.054. DISTRICT OR POLITICAL SUBDIVISION EXTENDING
- 2 INTO FEWER THAN FOUR COUNTIES: NOTICE TO PUBLIC AND COUNTY CLERKS;
- 3 PLACE OF POSTING NOTICE. (a) The governing body of a water
- 4 district or other district or political subdivision that extends
- 5 into fewer than four counties shall:
- 6 (1) post notice of each meeting at a place convenient
- 7 to the public in the administrative office of the district or
- 8 political subdivision; and
- 9 (2) either provide notice of each meeting to the
- 10 county clerk of each county in which the district or political
- 11 subdivision is located or post notice of each meeting on the
- 12 district's or political subdivision's Internet website.
- 13 (b) A county clerk shall post \underline{a} [the] notice provided to the
- 14 clerk under Subsection (a)(2) on a bulletin board at a place
- 15 convenient to the public in the county courthouse.
- 16 SECTION 3. The change in law made by this Act applies only
- 17 to notice for a meeting held on or after the effective date of this
- 18 Act. Notice for a meeting held before the effective date of this Act
- 19 is governed by the law in effect on the date the notice is given, and
- 20 the former law is continued in effect for that purpose.
- 21 SECTION 4. This Act takes effect September 1, 2015.
