Sections 215.004(a), (a-1), (b), and (c), Local 9 Government Code, are amended to read as follows: 10 11 (a) To protect the public health, safety, and welfare, a 12 municipality by ordinance: 13 (1) except as provided by Subdivision (2), shall 14 license, control, and otherwise regulate each private passenger vehicle, regardless of how it is propelled, that provides passenger 15 16 [taxicab] transportation services for compensation and is designed for carrying no more than eight passengers; and 17 18 (2) may license, control, and otherwise regulate each private passenger vehicle, regardless of how it is propelled, that 19 limousine transportation 20 provides passenger services for 21 compensation and is designed for carrying no more than 15 22 passengers. 23 (a-1) Subsection (a) applies to a passenger transportation 24 limousine] service that [taxicab or provides passenger

No. 3358 1 transportation services for compensation to passengers [is operated]: 2 3 (1) within the jurisdiction of the municipality; 4 on property owned by the municipality, singly or (2) 5 jointly with one or more other municipalities or public agencies; 6 (3) on property in which the municipality possesses an 7 ownership interest; or 8 (4) by transporting from the municipality, municipal property, or property in which the municipality has an interest and 9 10 returning to it. The ordinance may include: 11 (b) 12 (1)regulation of the entry into the business of providing passenger [taxicab or limousine] transportation services 13 for compensation[, including controls, limits, 14 or -other restrictions on the total number of persons providing the 15 16 services]; 17 (2) regulation of the rates charged for the provision of the services; 18 establishment 19 (3) of safety and insurance 20 requirements; and 21 any other requirement adopted to ensure safe and (4)reliable passenger transportation service. 22 23 (C) In regulating passenger [taxicab or limousine] 24 transportation services for compensation under this section, a municipality is performing a governmental function. 2 SECTION 3. This Act takes effect immediately if it receives 3 a vote of two-thirds of all the members elected to each house, as 4 provided by Section 39, Article III, Texas Constitution. If this 5 Act does not receive the vote necessary for immediate effect, this 6 Act takes effect September 1, 2015.
