A BILL TO BE ENTITLED

H.B. No. 3359

1 AN ACT

- 2 relating to requirements for coaches of youth sports programs.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Subtitle B, Title 13, Occupations Code, is
- 5 amended by adding Chapter 2053 to read as follows:
- 6 CHAPTER 2053. REQUIREMENTS FOR COACHES OF YOUTH SPORTS PROGRAM
- 7 Sec. 2053.001. DEFINITIONS. In this chapter:
- 8 (1) "Coach" means a person who provides training,
- 9 teaching, or similar services to participants in a youth sports
- 10 program.
- 11 (2) "Youth sports program" means an entity that
- 12 provides an organized athletic program that is not associated with
- 13 <u>a school and is for children who are enrolled in kindergarten</u>
- 14 through sixth grade in a public, private, or charter school or
- 15 children of similar age who are provided an education in a home
- 16 setting.
- 17 Sec. 2053.002. TRAINING AND CRIMINAL HISTORY RECORD CHECK
- 18 REQUIRED. (a) A person may not act as a coach for a youth sports
- 19 program unless the person has successfully completed a youth sports
- 20 training course that meets the requirements of this chapter and
- 21 rules adopted under this chapter and includes a criminal history
- 22 record check ascertaining whether the person is registered as a sex
- 23 offender under Chapter 62, Code of Criminal Procedure.
- 24 (b) A youth sports training course required by this section

- 1 may be offered or facilitated only by a sports foundation, a
- 2 nonprofit national youth sports organization that requires and
- 3 administers a participant certification program, a coaches
- 4 association, a national governing body as that term is defined by
- 5 the Ted Stevens Olympic and Amateur Sports Act (36 U.S.C. Section
- 6 220501), or a public or private high school or middle school
- 7 athletic department.
- 8 (c) A youth sports training course must include:
- 9 (1) at least two hours of in-person or online specific
- 10 sport skills-based coaching instruction; and
- 11 (2) at least two hours of in-person non-skills-based
- 12 coaching instruction that, at a minimum, addresses:
- 13 (A) the role of a youth sports coach;
- 14 (B) communication and accountability by and
- 15 between coaches, participants, and parents;
- 16 (C) suggestions for teaching and modeling life
- 17 skills;
- 18 (D) child developmental stages and corresponding
- 19 age-appropriate communication and discipline; and
- (E) the health, safety, and legal
- 21 <u>responsibilities of coaches.</u>
- Sec. 2053.003. LIABILITY INSURANCE INFORMATION. An
- 23 organization that provides a youth sports training course may offer
- 24 to coaches attending the course information on the availability of
- 25 liability insurance for the coaches and their players.
- Sec. 2053.004. RULES. The Texas Commission of Licensing
- 27 and Regulation may adopt the rules necessary to implement this

1 <u>chapter.</u>

- 2 SECTION 2. (a) Not later than December 1, 2015, the Texas
- 3 Commission of Licensing and Regulation shall adopt any rules
- 4 necessary to implement Chapter 2053, Occupations Code, as added by
- 5 this Act.
- 6 (b) The changes in law made by this Act apply only to a coach
- 7 who is coaching a youth sports program for a sports season that
- 8 begins on or after January 1, 2016. A coach who is coaching a youth
- 9 sports program during a sports season that began before that date is
- 10 governed by the law in effect immediately before the effective date
- 11 of this Act, and that law is continued in effect for that purpose.
- 12 SECTION 3. This Act takes effect September 1, 2015.
