- 7 to property designated by a state agency for transfer on or after
- 8 the effective date of this Act. State agency property that is
- 9 designated for transfer before the effective date of this Act is
- 10 governed by the law in effect on the date the designation was made,
- 11 and the former law is continued in effect for that purpose.
