- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Chapter 505, Health and Safety
- 6 Code, is amended to read as follows:
- 7 CHAPTER 505. MANUFACTURING FACILITY COMMUNITY RIGHT-TO-KNOW ACT;
- 8 <u>EMERGENCY NOTIFICATION ACT</u>
- 9 SECTION 2. Section 505.001, Health and Safety Code, is
- 10 amended to read as follows:
- 11 Sec. 505.001. SHORT TITLE. This chapter may be cited as the
- 12 Manufacturing Facility Community Right-To-Know Act and Emergency
- 13 Notification Act.
- 14 SECTION 3. The heading to Section 505.017, Health and
- 15 Safety Code, is amended to read as follows:
- 16 Sec. 505.017. NOTICE ISSUED UNDER EMERGENCIES; ALERT
- 17 SYSTEM.
- 18 SECTION 4. Section 505.017, Health and Safety Code, is
- 19 amended by adding Subsections (c) and (d) to read as follows:
- (c) If the responsible state agency determines that a
- 21 release will substantially endanger human health, the agency shall
- $\underline{\text{immediately notify persons in the area in which the facility is}}$
- 23 located of the release using the alert system established under
- 24 Subsection (d).

- (d) The state emergency response commission shall develop 1 2 and maintain an alert system to notify persons in the area in which the facility is located of a release that will substantially 3 endanger human health. The notification must be provided through 4 reverse 9-1-1 calls, text messages, e-mails, social media, and 5 6 other instant messaging systems. The commission may partner with 7 other state agencies in developing the alert system and shall allow persons to register for a preferred method of receiving a message 8 under the alert system. An alert issued by the system must include: 9 (1) each area affected by the release;

- (2) a link to an Internet website or other message 11
- 12 system that has updated information on each affected area;
- (3) the chemicals involved in and toxicity of the 13
- 14 release;
- 15 (4) the projected movement of the release; and
- 16 (5) instructions for protection from exposure to the
- 17 release.
- SECTION 5. Not later than September 1, 2016, the state 18
- emergency response commission shall establish the alert system as 19
- required by Section 505.017, Health and Safety Code, as amended by 20
- 21 this Act.
- SECTION 6. This Act takes effect September 1, 2015. 2.2
