 1-17 AN ACT

1-18 relating to judicial review of final orders arising out of  
 1-19 nutritional programs administrated by the Texas Department of  
 1-20 Agriculture.

1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 SECTION 1. Section 12.0025, Agriculture Code, is amended to  
 1-23 read as follows:

1-24 Sec. 12.0025. NUTRITION PROGRAMS. (a) The department  
 1-25 shall administer the following federal and state nutrition  
 1-26 programs:

1-27 (1) the commodity supplemental food program under 7  
 1-28 U.S.C. Section 612c;

1-29 (2) the food distribution program under 7 U.S.C.  
 1-30 Section 612c;

1-31 (3) the emergency food assistance program under 7  
 1-32 U.S.C. Section 7501 et seq.;

1-33 (4) the school lunch program under 42 U.S.C. Section  
 1-34 1751 et seq.;

1-35 (5) the summer food service program under 42 U.S.C.  
 1-36 Section 1761;

1-37 (6) the child and adult care food program under 42  
 1-38 U.S.C. Section 1766;

1-39 (7) the special milk program under 42 U.S.C. Section  
 1-40 1772; and

1-41 (8) the school breakfast program under 42 U.S.C.  
 1-42 Section 1773.

1-43 (b) A decision of the department's administrative review  
 1-44 official or the State Office of Administrative Hearings is the  
 1-45 final administrative determination of the department and not  
 1-46 subject to judicial review.

1-47 SECTION 2. This Act takes effect immediately if it receives  
 1-48 a vote of two-thirds of all the members elected to each house, as  
 1-49 provided by Section 39, Article III, Texas Constitution. If this  
 1-50 Act does not receive the vote necessary for immediate effect, this  
 1-51 Act takes effect September 1, 2015.
