8	(1) "Homeless veteran" means a person who has served

10	state military forces as defined by Section 437.001 and who:
11	(A) lacks a fixed, regular, and adequate
12	nighttime residence, including a person who is:
13	(i) temporarily allowed to stay in the
14	house of another person due to loss of housing;
15	(ii) temporarily living in a motel or
16	hotel;
17	(iii) living in an emergency shelter; or
18	(iv) abandoned in a hospital;
19	(B) has a primary nighttime residence that is a
20	public or private place not designed or ordinarily used as a regular
21	sleeping accommodation for humans; or
22	(C) is living in a car, park, other public space,
23	abandoned building, substandard housing, bus or train station, or
24	similar setting.

1 SECTION 2. This Act takes effect immediately if it receives 2 a vote of two-thirds of all the members elected to each house, as 3 provided by Section 39, Article III, Texas Constitution. If this 4 Act does not receive the vote necessary for immediate effect, this 5 Act takes effect September 1, 2015.
