- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 1702.230, Occupations Code, is amended
- 7 by amending Subsection (a) and adding Subsections (d), (e), and (f)
- 8 to read as follows:
- 9 (a) An application for registration or endorsement must be
- 10 verified and include:
- 11 (1) the applicant's full name, residence address,
- 12 residence telephone number, date and place of birth, and social
- 13 security number;
- 14 (2) a statement that:
- 15 (A) lists each name used by the applicant, other
- 16 than the name by which the applicant is known at the time of
- 17 application, and an explanation stating each place where each name
- 18 was used, the date of each use, and a full explanation of the
- 19 reasons the name was used; or
- 20 (B) states that the applicant has never used a
- 21 name other than the name by which the applicant is known at the time
- 22 of application;
- 23 (3) the name and address of the applicant's employer
- 24 and, if applicable, the applicant's consulting firm;

- 1 (4) the date the employment commenced;
- 2 (5) a letter from the license holder requesting that
- 3 the applicant be registered or endorsed;
- 4 (6) the title of the position occupied by the
- 5 applicant and a description of the applicant's duties; [and]
- 6 (7) the required fees, including the criminal history
- 7 check fee established under Section 1702.282;
- 8 (8) fingerprints of the applicant provided in the
- 9 manner prescribed by the board; and
- 10 <u>(9)</u> any other information, evidence, statement, or
- 11 document required by the board.
- 12 (d) For purposes of Subsection (a), an application is not
- 13 considered to be verified until the board has received electronic
- 14 verification from the department or the Federal Bureau of
- 15 Investigation, as applicable, that the applicant has submitted the
- 16 <u>applicant's fingerprints.</u>
- 17 (e) The board shall make information available to the public
- 18 concerning whether an applicant for registration or endorsement has
- 19 met the requirements under this chapter for performing a service
- 20 for which the registration or endorsement is required.
- 21 <u>(f) If information concerning an applicant is not made</u>
- 22 available under Subsection (e) before the 48th hour after the time
- 23 the applicant's fingerprints are submitted in accordance with
- 24 Subsection (a), the applicant may begin performing the duties of
- 25 employment for which the registration or endorsement is required,
- 26 other than duties as a commissioned security officer, if the
- 27 employer or its agent:

- 1 (1) verifies through the department's publicly
- 2 <u>accessible website that the applicant is:</u>
- 3 (A) not disqualified for the registration or
- 4 endorsement based on the applicant's criminal history; and
- 5 (B) not required to register as a sex offender
- 6 under Chapter 62, Code of Criminal Procedure; and
- 7 (2) maintains in the applicant's employee file a copy
- 8 of the search results obtained under Subdivision (1).
- 9 SECTION 2. Section 1702.230(a), Occupations Code, as
- 10 amended by this Act, applies only to an application for
- 11 registration or endorsement that is submitted to the Texas Private
- 12 Security Board on or after the effective date of this Act. An
- 13 application submitted before the effective date of this Act is
- 14 governed by the law in effect on the date the application was
- 15 submitted, and the former law is continued in effect for that
- 16 purpose.
- 17 SECTION 3. This Act takes effect September 1, 2015.
