relating to the Texas Department of Motor Vehicles fund.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

4 SECTION 1. On September 1, 2015, the Texas Department of

5 Motor Vehicles fund created by Section 1001.151, Transportation

Code, as enacted by Section 71, Chapter 1287 (H.B. 2202), Acts of 6

the 83rd Legislature, Regular Session, 2013, is re-created by this 7

Act as a special fund in the state treasury outside the general 8

revenue fund, and all revenue dedicated for deposit to the credit of 9

the Texas Department of Motor Vehicles fund by a provision of 10

11 Chapter 1287 (H.B. 2202), Acts of the 83rd Legislature, Regular

12 Session, 2013, is rededicated by this Act for that purpose.

13 SECTION 2. (a) On September 1, 2015, the comptroller shall

14 transfer to the credit of the Texas Department of Motor Vehicles

fund, as re-created by this Act, an amount from the state highway 15

fund equal to the total amount of fees collected or received by the 16

Texas Department of Motor Vehicles under Section 502.356, 17

Transportation Code, and former Section 502.1705, Transportation 18

Code, during the period beginning November 1, 2009, and ending 19

August 31, 2013. 20

21 To the extent that money from the state highway fund

22 transferred to the credit of the Texas Department of Motor Vehicles

23 fund as required by Subsection (a) of this section was, before

September 1, 2013, used as collateral or as a source of payment for 24

- 1 the repayment of a loan, bond, credit agreement, public security,
- 2 or other obligation, that amount remains subject to use as
- 3 collateral or as a source of payment for the obligation. However,
- 4 an obligation described by this subsection must be paid first from
- 5 the state highway fund, and the Texas Department of Motor Vehicles
- 6 fund is subject to payment of the obligation only to the extent the
- 7 state highway fund is depleted at the time the obligation matures
- 8 and becomes due.
- 9 SECTION 3. Except as specified by Section 2 of this Act, of
- 10 the revenue dedicated for deposit to the credit of the Texas
- 11 Department of Motor Vehicles fund by a provision of Chapter 1287
- 12 (H.B. 2202), Acts of the 83rd Legislature, Regular Session, 2013,
- 13 the comptroller shall deposit to the credit of that fund only
- 14 revenue received on or after the effective date of this Act.
- 15 SECTION 4. This Act takes effect September 1, 2015.
