- 9 SECTION 2. Section 8364.001(1), Special District Local Laws
- 10 Code, is amended to read as follows:
- 11 (1) "Authority" means the Lone Star [Corn Hill]
- 12 Regional Water Authority.
- SECTION 3. Section 8364.051, Special District Local Laws
- 14 Code, is amended by amending Subsection (c) and adding Subsection
- 15 (e) to read as follows:
- 16 (c) Except as provided by Subsection (e), each [Each] member
- 17 entity shall appoint two directors.
- 18 (e) If at any time the number of member entities is more than
- 19 five, the board may adopt a resolution providing that each member
- 20 entity shall appoint one director. A resolution adopted under this
- 21 subsection must be approved by an affirmative vote of not less than
- 22 <u>75 percent of the directors then serving, with at least one director</u>
- 23 from each member entity present and voting in favor of the
- 24 resolution. If the board passes a resolution under this subsection,

- 1 the terms of the directors then serving shall expire on the first

- 6 SECTION 4. (a) The legal notice of the intention to
- 7 introduce this Act, setting forth the general substance of this
- 8 Act, has been published as provided by law, and the notice and a
- 9 copy of this Act have been furnished to all persons, agencies,
- 10 officials, or entities to which they are required to be furnished
- 11 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 12 Government Code.
- 13 (b) The governor, one of the required recipients, has
- 14 submitted the notice and Act to the Texas Commission on

- 16 (c) The Texas Commission on Environmental Quality has filed
