- 1 WHEREAS, The citizens of Amarillo lost an exemplary public
- 2 official with the passing of city council member James Harold Simms
- 3 on November 12, 2014, at the age of 73; and
- WHEREAS, Born in Amarillo on January 1, 1941, Jim Simms was
- 5 raised in Clovis, New Mexico, and pursued his college education at
- 6 Eastern New Mexico University, where he earned degrees in business,
- 7 finance, and psychology; and
- 8 WHEREAS, Following graduation, Mr. Simms settled in
- 9 Amarillo; he operated the Mitchell Electric Company for 28 years
- 10 before selling the business in 1999, then worked for another 11
- 11 years as a vice president of Amarillo National Bank; and
- 12 WHEREAS, Mr. Simms began his distinguished career in public
- 13 service in 1982, when he was elected to the board of the Amarillo
- 14 Independent School District, and he held that office for five
- 15 years, including a stint as board president; during the 1990s, he
- 16 was president of the Amarillo Hospital District board of managers;

- 18 WHEREAS, In 2005, this respected civic leader was elected as
- 19 the Place 4 representative on the Amarillo City Commission, and he
- 20 went on to earn reelection four times, most recently in May 2013,
- 21 six months before the city commission converted to a council;
- 22 during his time in city government, he worked tirelessly to benefit
- 23 his community and played an important role in securing additional
- 24 water resources and furthering economic development efforts; and

- 1 WHEREAS, Mr. Simms was active in state government as well, accepting appointments from Governor George W. Bush as executive 2 3 chair of the board of trustees of the Teacher Retirement System of Texas and from Governor Rick Perry to become a member of the State 4 Securities Board; in addition, he was president of Kids Inc. and of 5 the Children's Learning Centers board of directors, and he worked 6 with United Way of Amarillo and Canyon; in recognition of his 7 8 accomplishments, he was named Man of the Year by the Amarillo
- 10 WHEREAS, A caring husband and father, Mr. Simms shared a 11 rewarding 57-year marriage with his wife, Freeda; they raised three 12 children, Jane, J. Fred, and Lee, and with the passing years, they 13 had the pleasure of seeing their family grow to include six 14 grandchildren; and
