- 2 passing of David Michael Braun of Nassau Bay on February 21, 2015,
- 3 at the age of 59; and
- WHEREAS, Born in East Cleveland, Ohio, to Dan and Sadie Braun
- 5 in 1955, David Braun grew up in Depew, New York; in 1986, he moved to
- 6 Nassau Bay, Texas, and he earned a degree in marketing from the
- 7 University of Houston; and
- 8 WHEREAS, After working in sales for a number of years,
- 9 Mr. Braun joined the Bay Area Houston Economic Partnership in 2005
- 10 as aerospace marketing manager, and in that position he was able to
- 11 follow his passion as a strong advocate in behalf of manned space
- 12 flight; every year, he coordinated a visit to Washington, D.C., by
- 13 150 people, who spent two days promoting funding for the space
- 14 program in more than 350 congressional offices; and
- 15 WHEREAS, Mr. Braun was also a leader in his community at
- 16 home, serving on the Nassau Bay City Council from 2002 to 2010, and
- 17 during his tenure he was instrumental in the development of Nassau
- 18 Bay Town Center; after taking a year off from the council because of
- 19 term limits, he was reelected in 2011, when he was named mayor pro
- 20 tem; as a member of the Coalition for Sustainable Flood Insurance,
- 21 he played a role in the passage of the Homeowner Flood Insurance
- 22 Affordability Act; and
- WHEREAS, Among his many other good works, Mr. Braun
- 24 volunteered with the Nauticats Swim Team for 12 years, and he and

- 1 his family often hosted students from around the world through the
- 2 United Space School and the Texas A&M Singing Cadets; a man of
- 3 strong religious faith, he assisted with catechism classes at
- 4 St. Paul the Apostle Catholic Church, and he also sponsored engaged
- 5 couples to prepare them for marriage and served on the church's
- 6 building committee; and
- WHEREAS, Mr. Braun's awards include recognition from the
- 8 Clear Creek Education Foundation as Citizen of the Year, and in
- 9 2009, the University of Houston presented him with the
- 10 Distinguished Alumni Award; and
- 11 WHEREAS, During his time on this earth, David Braun lived
- 12 life to the fullest, dedicating himself to his family, his faith,
- 13 and the city he loved, and he will long be fondly remembered by all
- 14 those who were fortunate enough to know him; now, therefore, be it

- 16 hereby pay tribute to the memory of David Michael Braun and extend
- 17 sincere condolences to the members of his family: to his wife,
