1 WHEREAS, Texas athletes have a long history of excelling at 2 the highest levels of competition, and Clint Dempsey of the United

3 States Men's National Team furthered that tradition with his

4 exemplary performance at the 2014 FIFA World Cup in Brazil; and

5 WHEREAS, Mr. Dempsey shined throughout the tournament,

6 starting all four of the USMNT matches and scoring two crucial goals

7 from his forward position; in the process, he helped the United

8 States advance out of the group stage and into the Round of 16,

9 while becoming the first American player to score in three

10 consecutive World Cups; and

11 WHEREAS, This superb athlete tallied his first goal in the

12 team's opening match against Ghana, evading his defender in the

penalty area and placing a perfect shot inside the goalposts to give

14 the U.S. a lead just 32 seconds into the contest; Mr. Dempsey also

15 displayed rare grit and determination by remaining on the field

16 after suffering a broken nose late in the first half, as the U.S.

17 won by a score of 2-1; in the ensuing matchup with Portugal, he

18 deftly controlled a crossing pass from teammate Graham Zusi in the

19 81st minute and put the ball in the back of the net for a late

20 go-ahead goal; and

21 WHEREAS, A member of the national team since 2004,

22 Mr. Dempsey has been recognized for his efforts during

23 international competition with a number of accolades, including

24 three U.S. Soccer Male Athlete of the Year awards and three Futbol

- 2 FIFA Bronze Ball at the 2009 Confederations Cup for his attacking
- 3 style of play; and
- 4 WHEREAS, Mr. Dempsey was a standout performer on the
- 5 Nacogdoches High School soccer team, and he went on to achieve
- 6 notable success in college as an All-American midfielder and
- 7 forward for Furman University; he was drafted in 2004 by Major
- 8 League Soccer's New England Revolution, where he scored 25 goals in
- 9 three seasons before continuing his professional career overseas
- 10 with the Fulham Football Club and the Tottenham Hotspurs Football
- 11 Club of the English Premier League; in 2013, he returned to the U.S.
- 12 and his MLS roots by transferring to the Seattle Sounders Football
- 13 Club, leading the team to a berth in the MLS Cup Playoffs; and
- WHEREAS, Clint Dempsey has distinguished himself as one of
- 15 the finest footballers to ever wear the red, white, and blue, and
- 16 his accomplishments on the game's biggest stage are a source of
- 17 great pride and excitement for his many fans across the country and
- 18 in the Lone Star State; now, therefore, be it
- 19 RESOLVED, That the House of Representatives of the 84th Texas
- 20 Legislature hereby congratulate Clint Dempsey on his performance as
