

R E S O L U T I O N

1           WHEREAS, The citizens of Brady are mourning the loss of  
2 police chief Charles Edward Derrick, who passed away on December  
3 21, 2014, at the age of 57; and

4           WHEREAS, Charlie Derrick was born in Dallas to Charles and  
5 Mary Derrick on August 25, 1957; he graduated from the Texas  
6 Department of Public Safety Academy in 1980 and was assigned to the  
7 driver's license division in Farmers Branch for one year; this fine  
8 officer then realized a lifelong dream in 1981, when he became a  
9 highway patrol officer; he served in that capacity in Corsicana for  
10 eight years and later worked as a narcotics officer and trainer in  
11 Del Rio, Austin, and San Angelo; and

12           WHEREAS, Chief Derrick was a member of the DPS Post-Seizure  
13 Analysis Team from 1997 to 2001, and during that time he also  
14 attended the FBI Academy; after returning to narcotics training for  
15 a time, he spent six years as gun range master at the DPS firearms  
16 range in Florence, where he worked with recruits until his  
17 retirement in 2009; and

18           WHEREAS, Following his exemplary tenure with DPS, Chief  
19 Derrick moved to Brady and assumed the post of chief of police;  
20 during his more than five years in that office, he set an inspiring  
21 example of professionalism and integrity while admirably serving  
22 the citizens of Brady and McCulloch County; and

23           WHEREAS, In all his endeavors, Chief Derrick enjoyed the love  
24 and support of his wife of more than three decades, Chris Derrick,

1 and he took great pride in their three sons, Jason, Stephen, and  
2 Samuel, as well as their five grandchildren; a man of deep faith, he  
3 was an active congregant of Hill Country Bible Church in Austin,  
4 where he served as an elder; and

5 WHEREAS, Charles Derrick dedicated his life to protecting the  
6 safety of others, and in so doing, he embodied the highest ideals of  
7 the law enforcement profession; now, therefore, be it

8 RESOLVED, That the House of Representatives of the 84th Texas  
9 Legislature hereby pay tribute to the life of Chief Charles Edward  
10 Derrick and extend sincere sympathy to the members of his family: to  
11 his wife of 31 years, Chris Derrick; to his sons, Stephen Derrick  
12 and Jason Derrick and his wife, Kosal; to his grandchildren, Emma,  
13 Payton, Grace, Ethan, and Caleb; to his sister, Melanie Brown, and  
14 her husband, Gary; and to his many other relatives and friends; and,
