- 1 WHEREAS, The people of San Antonio lost a beloved, longtime
- 2 civic leader with the passing of Elvira Cisneros on November 22,
- 3 2014, at the age of 90; and
- WHEREAS, Born on July 11, 1924, in Puebla, Mexico, the former
- 5 Elvira Munguia was the daughter of political activists Romulo and
- 6 Carolina Munguia; her family immigrated to the United States when
- 7 she was two years old, settling in San Antonio's Prospect Hill
- 8 neighborhood, where they soon became business and community
- 9 leaders; after graduating from Jefferson High School, Elvira
- 10 Munguia attended The University of Texas at Austin before returning
- 11 to San Antonio in 1942 to help out in the family print shop while her
- 12 brothers served in World War II; she continued her education at
- 13 Draughon's Business College and later took a position at Frost
- 14 Bank; and
- WHEREAS, In 1945, Elvira Munguia married George Cisneros, a
- 16 veteran from Colorado, after a whirlwind courtship; they became the
- 17 proud parents of five beloved children, each of whom has
- 18 contributed to society either through public service or through
- 19 other professional endeavors; and
- WHEREAS, While her family always came first in her life,
- 21 Mrs. Cisneros also devoted her time and energy to many
- 22 philanthropic organizations; she advised the Alamo Area Council of
- 23 Governments on issues related to seniors and served on the boards of
- 24 the Avenida Guadalupe Association, AVANCE, and Project Learn to

- 1 Read; after her husband's stroke, she aided him in establishing the
- 2 San Antonio Stroke Club and in performing his duties as the national
- 3 spokesperson on strokes for Easter Seals; in addition, she was a
- 4 devout congregant of the Basilica of the National Shrine of the
- 5 Little Flower; and
- 6 WHEREAS, Mrs. Cisneros received numerous accolades for her
- 7 service to the community, including the Alexis de Tocqueville
- 8 Society Centennial Award, which was presented to her by President
- 9 Gerald Ford on behalf of the United Way, and a medal from President
- 10 Ronald Reagan for her work with Easter Seals; in 1991, she was
- 11 inducted into the San Antonio Women's Hall of Fame in recognition of
- 12 her outstanding civic leadership, and WellMed named the Elvira
- 13 Cisneros Senior Community Center in her honor in 2009; and
- 14 WHEREAS, Through her myriad endeavors, Elvira Cisneros
- 15 contributed to building a more inclusive, caring, and vibrant
- 16 community, and those who were privileged to share in her love and
- 17 affection will forever hold her close in their hearts; now,
- 18 therefore, be it

- 20 Legislature hereby pay tribute to the life of Elvira Cisneros and
- 21 extend sincere sympathy to the members of her family: to her
