9 Resistance Education classes in Denton County schools and was

10 honored as the 1996 DARE Officer of the Year; and

11 WHEREAS, Following her completion of a degree in criminal

justice, Ms. Johnson took a part-time job at the local justice of

13 the peace office; her rewarding experiences in that position later

14 inspired her to run for justice of the peace for Precinct 2 of Wise

15 County; she took office on January 1, 2007, and was reelected four

16 years later, and in the course of her tenure, she earned the respect

17 of her peers and the appreciation of the public; in addition to

18 fulfilling her duties as justice of the peace, she served on the

19 criminal justice and juvenile grant review boards of the North

20 Central Texas Council of Governments and acted as secretary for the

21 Texas Justice Court Judges Association; and

22 WHEREAS, This esteemed Texan also played an active role in

23 her community in other ways; she volunteered with the American

24 Diabetes Association, taught for Junior Achievement, and served as
