## RESOLUTION

1 WHEREAS, Residents of Wise County lost a dedicated public 2 servant and community leader with the passing of County Judge Bill 3 McElhaney of Bridgeport on October 14, 2013, at the age of 67; and WHEREAS, Bill McElhaney was born in Decatur on June 17, 1946, 4

5 to Joseph and Atrel McElhaney; after earning his diploma in 1964

from Bridgeport High School, he enlisted and served in the United 6

States Army from 1965 to 1967; he went on to graduate in 1977 from 7

the University of North Texas, where he obtained his bachelor's 8

degree in finance with a minor in real estate; and

9 WHEREAS, In 1968, Mr. McElhaney was hired by TXI Operations 10 11 in Chico, beginning a career with the building materials supplier 12 that would span nearly four decades; he worked in various supervisory and managerial positions before moving into corporate 13 14 reserves and business development for Texas and Oklahoma in 1997 and accepting a position as corporate mineral land manager in the 15 16

firm's real estate division four years later; and WHEREAS, Mr. McElhaney's deep commitment to the community 17 led him to participate in numerous civic endeavors over the course 18 of a quarter-century; he served on the Bridgeport City Council from 19 1978 to 1980, and he first won election as county judge in 2006; 20 21 while fulfilling his duties on the commissioners court, he took it upon himself to expand his knowledge by taking hundreds of hours of 22 23 judicial education courses; a member of the Fellows of the Texas County Judges Judicial Academy, he also belonged to the V. G. Young 24

- 1 Commissioners Court Leadership Academy and was active in the
- 2 Nor-Tex County Judges Association; and
- 3 WHEREAS, This esteemed Texan further benefited his hometown
- 4 as chair of the Bridgeport Economic Development Board from 1988 to
- 5 1989 and was vice president of the executive board for the North
- 6 Central Texas Council of Governments at the time of his passing;
- 7 moreover, he contributed his expertise as a member of the
- 8 Bridgeport ISD Board of Trustees for a total of 21 years, and he
- 9 served on the board for the Wise County School District as well; and
- 10 WHEREAS, In all his endeavors, Judge McElhaney enjoyed the
- 11 love and support of his wife, Kim, and he took great pride in his
- 12 children, Billy, Blaine, Stacie, and Katie, as well as in his 10
- 13 grandchildren; and
- 14 WHEREAS, Bill McElhaney was an accomplished professional who
- 15 also devoted himself to making Wise County an even better place to
- 16 live, and he leaves behind a record of good works that will be
- 17 admired for years to come; now, therefore, be it
