- 10 contest, and conducted the Graham Toy Symphony Band, among other

- 13 Vaughan in Altus, Oklahoma, in 1935, and they settled in Graham in
- 14 the early 1950s; the couple shared a fulfilling relationship for 58
- 15 years until Mr. Vaughan's passing in 1993; and
- 16 WHEREAS, Mrs. Vaughan joined the faculty of Graham High
- 17 School, and she taught piano and voice to countless local residents
- 18 during a career that spanned many decades; even after her
- 19 retirement from the school in 1976, she continued to serve as an
- 20 advisor to the theater program and its students; she has graced the
- 21 stage at innumerable events, and in May 2012, the Graham Leader
- 22 reported that she stole the show as a presenter at the Graham High
- 23 School Scholarship Ceremony; and
- 24 WHEREAS, Deeply committed to her community, Mrs. Vaughan was

- 1 a charter member of the Graham Hospital Auxiliary and the Graham
- 2 Concert Association, and she has belonged to the Daughters of the
- 3 American Revolution for 60 years; she has also given generously of
- 4 her time and talents to the Rotary Club, the Rotary Follies, Graham
- 5 Regional Theatre, and the Graham Concert Series; named Citizen of
- 6 the Year, she was recognized twice by the Graham Chamber of Commerce
- 7 for her contributions, and in January 2015, the city council
- 8 approved plans to create a small park in her honor next to Graham
- 9 Memorial Auditorium; and
- 10 WHEREAS, Alwana Vaughan has earned a special place in the
- 11 hearts of her fellow citizens, and it is truly a pleasure to honor
- 12 her for having joined an elite group of Texans who can look back on
