- 8 teams at Lockhart High School; soon after graduation in 1980, he
- 9 joined Bluebonnet Electric Cooperative, where he worked as a
- 10 journeyman lineman and construction crew supervisor during a career
- 11 that spanned nearly three and a half decades; and
- 12 WHEREAS, In 1998, Mr. Roland became the first African
- 13 American to be elected to the Lockhart City Council; he served as
- 14 District 1 council member until 2010 and as at-large council member
- 15 from 2013 to 2015; dedicated to building a stronger community and
- 16 enriching the lives of his fellow residents, he founded the
- 17 District 1 Pride organization and in 2004, he played a key role in
- 18 coordinating the first annual MLK Parade in Lockhart; and
- WHEREAS, A devoted family man, Mr. Roland enjoyed the love
- 20 and support of his wife, Catherine, and he was adored by his
- 21 daughter, Kennedy; and
- WHEREAS, While the life of Kennedy Clay Roland ended far too
- 23 soon, the generosity, integrity, and kindness with which he lived
- 24 will forever inspire all who had the good fortune to know him; now,
