- 9 Mr. Franz enrolled at UTPA, where he earned a bachelor's degree in
- 10 political science in 1981; while pursuing his undergraduate
- 11 studies, he was appointed to the post of municipal court judge in
- 12 Hidalgo, an office he assumed a the age of 18; Mr. Franz went on to
- 13 attend The University of Texas School of Law and attained his doctor
- 14 of jurisprudence degree in 1984; he became a board certified
- 15 personal injury trial lawyer in 1989, and that same year, he opened
- 16 a law practice in McAllen; and
- 17 WHEREAS, John David Franz was elected mayor of Hidalgo in
- 18 1990, and he served in that office for 22 uninterrupted years; over
- 19 the course of his tenure, the city saw a number of significant
- 20 improvements, such as the construction of the State Farm Arena in
- 21 2003, and received many honors, including being named an
- 22 All-America City in 2004; and
- WHEREAS, Mr. Franz has also provided valued leadership to
- 24 many civic organizations, among them the Hidalgo Economic

- 1 Development Corporation, which he served for 22 years as a
- 2 director, the Lower Rio Grande Valley Development Council, which he
- 3 served for 15 years as president, and the Texas Border Coalition,
- 4 which he also served as president; in recognition of his myriad
- 5 contributions to the development of his region, John David Franz
- 6 was named Border Texan of the Year in 2009; and
- 7 WHEREAS, This esteemed gentleman has rendered further public
- 8 service as a member the Texas Criminal Justice Board, to which he
- 9 was appointed by Governor George W. Bush in 1995; during his term on
- 10 the board, he played an instrumental role in laying the foundation
- 11 for the modernization of the system's aging physical plant; and
- WHEREAS, In all his endeavors, Mr. Franz enjoys the love and
- 13 support of his wife, Annette Diaz, and his children, John and
- 14 Steven; and
- WHEREAS, Benefiting from the solid educational foundation
- 16 that he received at UTPA, John David Franz has made lasting
- 17 contributions to his community and to the State of Texas, and he is
