- 7 went on to earn an associate's degree in law enforcement from Alvin

- 9 of criminal justice from the University of Houston--Clear Lake in
- 10 1977; and
- 11 WHEREAS, First elected Brazoria County Judge in 2006, Judge
- 12 King served with notable dedication throughout his tenure; he
- 13 brought to the position a wide range of experience that he gained
- 14 through an impressive career in law enforcement, which included
- 15 nearly a quarter-century as Brazoria County Sheriff, as well as
- 16 service as a trooper with the Texas Department of Public Safety, a
- 17 lieutenant with the Brazoria Police Department, and a law
- 18 enforcement instructor at Brazosport Community College; he also
- 19 completed training at the FBI National Academy in Quantico,
- 20 Virginia, in 1986; and

- 8 Association, and the Brazoria County Fair Association, and he has
- 9 also been active in the Texas and Southwestern Cattle Raisers

- 11 County; he is a valued congregant of Most Holy Trinity Catholic
- 12 Church; and
- 13 WHEREAS, In recognition of his contributions to his
- 14 profession and his community, Judge King was presented with the
- 15 2011 Distinguished Alumnus Award from the University of
- 16 Houston--Clear Lake, the 2007 Outstanding Alumnus Award from the
