- 1 WHEREAS, The Corpus Christi Chamber of Commerce is
- 2 celebrating its 100th anniversary in 2016; and
- 3 WHEREAS, The chamber was founded in 1916 to foster economic
- 4 growth and serve as a voice for the business community; the
- 5 organization's early advocacy was instrumental in the construction
- 6 of a seawall to avert flooding, as well as in the creation of the
- 7 Port of Corpus Christi in 1926; today, the port ranks as the sixth
- 8 largest in the nation; and
- 9 WHEREAS, Soon after its establishment, the chamber
- 10 recognized the importance of tourism, and it bought land that was
- 11 later used for the city's first golf course; before World War II,
- 12 members of the organization began persuading military and
- 13 government officials to build a base in the area, and the Corpus
- 14 Christi Naval Air Station opened in 1941; and
- WHEREAS, Over the years, the chamber has enhanced
- 16 recreational opportunities for tourists and residents alike
- 17 through its endeavors in behalf of the area's natural resources; it
- 18 has supported the conservation of the Padre Island National
- 19 Seashore and Mustang Island State Park and the establishment of the
- 20 Texas State Aquarium for the study of plants and animals native to
- 21 the Gulf of Mexico; and
- WHEREAS, While assisting in business recruitment and serving
- 23 the needs of small businesses, the chamber has also been involved in
- 24 numerous projects in recent years; it played a key role in winning

- 1 voter approval to raise the JFK Causeway over the Packery Channel,
- 2 and it promoted the repair of the seawall and the expansion of the
- 3 Convention Center; in addition, it has advanced such causes as the
- 4 Harbor Bridge, Interstate Highway 37, the Wesley Seale and Choke
- 5 Canyon Dams, and the merger of Texas A&M University with Corpus
- 6 Christi State University; and
- 7 WHEREAS, The Corpus Christi Chamber of Commerce has greatly
- 8 benefited the city and the region over the course of its long
- 9 history, and it is indeed appropriate to recognize its outstanding
- 10 contributions to the Coastal Bend community as it marks this
- 11 significant milestone; now, therefore, be it

- 13 Legislature hereby congratulate the Corpus Christi Chamber of
- 14 Commerce on its centennial and extend to its members sincere best
