1 WHEREAS, Residents of Sabine County lost an admired public
2 official and a cherished friend with the passing of the Honorable
3 Charles Edward Watson on April 8, 2014, at the age of 78; and

4 WHEREAS, Born in Centralia on October 6, 1935, to O. B. and
5 Mary Watson, Charles Watson served in the United States Air Force
6 from 1955 to 1959; following his return to civilian life, he enjoyed
7 a successful career with CenterPoint Energy that spanned more than
8 three and a half decades; and

9 WHEREAS, This esteemed gentleman moved to Rosevine in 1996
10 and was first elected to public office a decade later, when the
11 voters of Sabine County selected him as county judge; his
12 exceptional efforts earned him reelection in 2010, and he continued
13 to gain the respect of colleagues and area residents alike; known
14 for his encouraging attitude and his concern for others, Judge
15 Watson worked tirelessly to advance the common good and exemplified
16 the highest standards of public service; and

17 WHEREAS, A caring husband and father, Judge Watson shared
18 many rewarding years with his wife, Barbara, and took great pride in
19 their three children, Wyatt, Damon, and Deena; with the passing of
20 time, he also had the pleasure of seeing his family grow to include
21 8 grandchildren and 17 great-grandchildren; Judge Watson attended
22 First United Methodist Church in Hemphill, where he was a valued
23 member of the congregation; and

1 WHEREAS, Devoted to his family and his community, Charles
2 Watson made a meaningful difference in the lives of his loved ones
3 and fellow citizens alike, and although he is deeply missed, his
4 contributions will be fondly remembered for years to come; now,
5 therefore, be it

7 Legislature hereby pay tribute to the life of the Honorable Charles
8 Edward Watson and extend sincere sympathy to the members of his
