RESOLUTION

- 1 WHEREAS, Texas State Technical College is celebrating its
- 2 50th anniversary in 2015, and the attainment of this milestone
- 3 offers a fitting opportunity to celebrate this unique educational
- 4 institution; and
- 5 WHEREAS, Created by Governor John Connally and the 59th Texas
- 6 Legislature in April 1965, the James Connally Technical Institute
- 7 of Texas A&M University was intended from the start to be, in the
- 8 words of Governor Connally, "the most sophisticated
- 9 technical-vocational institute in the country"; and
- 10 WHEREAS, Under the leadership of its first director, Dr. Roy
- 11 Dugger, JCTI opened its first campus at the former James Connally
- 12 Air Force Base in Waco, and in 1967, the institute opened a
- 13 bilingual technical institute at the former Harlingen Air Force
- 14 Base; and
- WHEREAS, JCTI was made independent of Texas A&M in 1969 and
- 16 renamed the Texas State Technical Institute; over the next two
- 17 decades, the success of TSTI led to the creation of additional
- 18 campuses in Amarillo, Sweetwater, McAllen, Abilene, Breckenridge,
- 19 Brownwood, and Marshall; and
- WHEREAS, In 1991, the Texas Legislature elevated the status
- 21 of the campuses, designating them as two-year technical colleges
- 22 with a new name, Texas State Technical College, and in 2013, the
- 23 funding method for the TSTC System was placed on a "returned-value"
- 24 basis, making it the first college system in the nation whose

- 1 funding depends entirely on student success; in the years since
- 2 that change, TSTC has seen a 23 percent increase in student awards,
- 3 and a 60 percent increase in first-year earnings for graduates; and
- 4 WHEREAS, Today, working in close collaboration with
- 5 industry, government agencies, and other institutions of higher
- 6 learning, the 11 locations of the TSTC System across the Lone Star
- 7 State offer vocational students 124 associate degrees and 133
- 8 certificate programs, preparing them for successful, well-paying
- 9 careers through excellence in technical education; and
- 10 WHEREAS, During its first half-century, the TSTC System has
- 11 produced nearly 100,000 graduates and truly lived up to the vision
- 12 of its founders by becoming one of the most sophisticated technical
- 13 and vocational institutions in the nation; now, therefore, be it
- RESOLVED, That the House of Representatives of the 84th Texas
- 15 Legislature hereby commemorate the 50th anniversary of Texas State
- 16 Technical College and extend to its administration, staff, and
- 17 students sincere best wishes for continued success; and, be it
- 18 further
- 19 RESOLVED, That an official copy of this resolution be
- 20 prepared for Texas State Technical College as an expression of high
- 21 regard by the Texas House of Representatives.
