- 1 WHEREAS, The Texas State Aquarium in Corpus Christi is
- 2 celebrating the 30th anniversary of its designation as the Official
- 3 Aquarium of Texas in 2015; and
- WHEREAS, A project launched by the Junior League of Corpus
- 5 Christi and the local Jaycees in 1969, the aquarium gained early
- 6 support from members of Leadership Corpus Christi Alumni, the Earl
- 7 C. Sams Foundation, and the Brown Foundation of Houston; the Texas
- 8 Legislature conferred the official designation in 1985, and the
- 9 aquarium opened to the public five years later; and
- 10 WHEREAS, The aquarium has flourished as a private,
- 11 not-for-profit organization, maintaining its operations through
- 12 general admissions, memberships, retail sales, event rentals, and
- 13 the generosity of donors; in addition to exhibitions, it sponsors
- 14 education, conservation, and wildlife rehabilitation; over the
- 15 years, it has worked to save protected, threatened, and endangered
- 16 species, and it has cared for countless stranded or injured
- 17 creatures, among them marine mammals, sea turtles, raptors, and
- 18 shorebirds; and
- 19 WHEREAS, In 2014, the aquarium opened the Nearshore
- 20 Experience, an immersive indoor exhibit, and it hosted the
- 21 groundbreaking for an expansion project that will more than double
- 22 the size of the institution; the institution also became one of only
- 23 six aquariums in the nation to achieve Charity Navigator's
- 24 prestigious four-star rating for good governance, sound fiscal

- 1 management, accountability, and transparency; and
- 2 WHEREAS, The Texas State Aquarium is dedicated to connecting
- 3 people with nature and promoting the conservation of the Gulf of
