RESOLUTION

1 WHEREAS, Words cannot adequately express the sorrow felt at 2 the loss of Kelly Walters of Arlington, a remarkable young woman 3 whose life was tragically cut short on January 16, 2015, at the age 4 of 20; and

5 WHEREAS, Adopted from the Gladney Center when she was only 6 two weeks old, Kelly Walters was a lively, inquisitive, and 7 physically daring child from a very early age, whether it was 8 swinging from the monkey bars at day care, playing on the roof with 9 a friend, or riding a goat at a birthday party without the goat's 10 permission; and

11 WHEREAS, Ms. Walters first showed signs of a budding interest 12 in politics in the first grade; when she complained about some rules at school, her mother explained to her that the rules were set by 13 14 the school board and the State Board of Education, and Ms. Walters decided that she needed to become president of the United States, 15 16 even writing to President Bill Clinton and offering to take over the job during the contested election of 2000; on another occasion, 17 after she was written up by her teacher for poking another student 18 with a pencil, the indomitable Ms. Walters wrote under 19 the teacher's comments, "needs more pencils"; and 20

21 WHEREAS, At the age of seven, Ms. Walters watched the 22 coverage of the attack on New York on September 11, 2001, with her 23 mother, and after reading a book about a young girl in Afghanistan 24 who poses as a boy to feed her family, she was inspired to help women

1 and girls in the Arab world, a passion that continued into her 2 adulthood; and

3 WHEREAS, Ms. Walters began asking questions at the town hall 4 meetings of U.S. Representative Joe Barton when she was in her 5 teens, and when she was 17, he sponsored her as a page in the U.S. 6 Congress; close to home, she volunteered with the Tarrant County 7 Republican Party, was a leading member of the Arlington Republican 8 Club, and served as an election judge on several occasions; and

WHEREAS, graduating 9 After from Lamar Hiqh School, 10 Ms. Walters enrolled in The University of Texas at Arlington, where she was double-majoring in psychology and political science; she 11 12 was also studying Arabic, intending to follow through on her youthful commitment to work for women's rights in the Arab world; at 13 14 the time of her death, she was planning to leave for an intensive 15 Arabic immersion program in Morocco; and

16 WHEREAS, Ms. Walters also showed her idealism and her concern 17 for others in her personal life on a daily basis, helping out 18 friends in need, taking an interest in individuals of all 19 backgrounds and beliefs, and earning the respect of people of all 20 ages with her intelligence, compassion, and maturity; and

21 WHEREAS, During her years on this earth, Kelly Walters 22 demonstrated a passion for life and a steadfast commitment to the 23 causes in which she believed, and her legacy will continue to 24 inspire all those who were privileged to know her; now, therefore, 25 be it

26 RESOLVED, That the House of Representatives of the 84th Texas 27 Legislature hereby pay tribute to the memory of Kelly Walters and
