- 2 respected member of the legal community with the passing of Horacio
- 3 Paul Guerra III on December 27, 2013, at the age of 81; and
- WHEREAS, Born to Horace P. Guerra, Jr., and Rebeca H. Guerra
- 5 in Rio Grande City, H. P. Guerra graduated from Rio Grande City High
- 6 School in 1950; he answered his nation's call to duty and spent two
- 7 years in the U.S. Army during the Korean War, reaching the rank of
- 8 lieutenant colonel; he continued his service as a member of the U.S.
- 9 Army Reserve for 20 years; after his return to civilian life, Mr.
- 10 Guerra attended St. Mary's University and earned his bachelor's and
- 11 law degrees in 1955; he later obtained his doctor of jurisprudence
- 12 degree in 1966; and
- WHEREAS, Admitted to practice before the U.S. Supreme Court
- 14 and the U.S. Court of Military Appeals, this distinguished legal
- 15 professional held membership in the State Bar of Texas for more than
- 16 half a century and spent over three decades practicing law in Rio
- 17 Grande City; Mr. Guerra demonstrated a strong work ethic throughout
- 18 his time in Rio Grande City, and he often put in long hours while
- 19 serving a number of clients on a pro bono basis; moreover, he acted
- 20 as legal counsel for the Starr County Appraisal District for
- 21 several years; and
- 22 WHEREAS, Mr. Guerra was also employed in the banking
- 23 industry, and he held various management positions at a number of
- 24 financial institutions in Rio Grande City, San Antonio, and

- 1 McAllen; in 1970, he was appointed to the Finance Commission of
- 2 Texas for a six-year term by Governor Preston Smith; and
- 3 WHEREAS, Committed to supporting his hometown, Mr. Guerra
- 4 shared his time with numerous worthwhile organizations over the
- 5 years; he was a charter member of the local chapter of Rotary
- 6 International, a member of El Cid Caravan No. 106 of the
- 7 International Order of Alhambra, and a past Grand Knight of the De
- 8 Saules Council of the Knights of Columbus No. 2595; in addition, he
- 9 served as president of the Rio Grande City Jaycees and as an
- 10 honorary member of the Monterrey, Nuevo Leon, Mexico Jaycee Club,
- 11 and he further contributed to the U.S. Jaycees as an ambassador to
- 12 El Salvador and to Central and South America; he was also a
- 13 parishioner at Immaculate Conception Church; and
- WHEREAS, In all his endeavors, Mr. Guerra enjoyed the love
- 15 and support of his wife, Josie, and the couple were blessed with
- 16 three children and eight grandchildren; and
- 17 WHEREAS, A man of integrity who believed in working hard and
- 18 in treating everyone with respect, H. P. Guerra contributed greatly
- 19 to the Rio Grande City community, and he leaves behind a record of
- 20 service that his loved ones can remember with pride; now,
