- 16 WHEREAS, Mr. Adams continued to develop his expertise over
- 17 the years, specializing in consumer, real estate, and family law;
- 18 he went on to create an independent firm in Universal City, where
- 19 his strong reputation among municipal leaders won him the position
- 20 of city attorney; he additionally served as the staff attorney for
- 21 the economic development corporations of Hollywood Park and
- 22 Windcrest and as an attorney for business magnate Red McCombs, with
- 23 whom he shared a close friendship; and
- 24 WHEREAS, Harry Adams's commitment to his community and

- 1 profession was surpassed only by his devotion to his family; he
- 2 enjoyed a rewarding marriage of nearly five decades with his wife,
- 3 the former Beverly Ball, and he took great pride in his children,
- 4 Terra and Harry, and in his seven grandchildren; passionate about
- 5 travel, Mr. Adams ventured with his wife to destinations as
- 6 far-flung as Africa, Holland, Jerusalem, and Hawaii, and when at
- 7 home, he enjoyed preparing gourmet dishes for friends and family; a
