- 17 Appraisal District, and the Kaufman-Van Zandt-Rockwall Soil and
- 18 Water Conservation District; he further distinguished himself as a
- 19 founding member of the Wills Point Rodeo Club and as a member of the
- 20 Texas and Southwestern Cattle Raisers Association, and he was a
- 21 valued congregant of the First Baptist Church in Wills Point for
- 22 more than 90 years; and
- 23 WHEREAS, Mr. Deen shared nearly six decades of marriage with
- 24 his wife, the former Mary Sue Hall, until her passing in 2001; he
