

R E S O L U T I O N

1           WHEREAS, Sweeny Community Hospital is marking the 50th  
2 anniversary of its founding on March 29, 2015, and this milestone  
3 provides an ideal opportunity to recognize this noteworthy  
4 institution; and

5           WHEREAS, In 1963, the Sweeny Hospital District was formed by  
6 the Texas Legislature in southwestern Brazoria County, following a  
7 decade-long effort on the part of the community to increase health  
8 care accessibility in rural areas; on March 29, 1965, Sweeny  
9 Community Hospital opened its doors, and it has since expanded its  
10 services, staff, and facilities to continue to meet the needs of the  
11 region; and

12           WHEREAS, Sweeny Community Hospital is a 24-hour operational  
13 critical access hospital that offers both inpatient and outpatient  
14 care; a member of the Texas Hospital Association and the Texas  
15 Organization of Rural & Community Hospitals, it serves as a Level IV  
16 Trauma Center and houses 20 beds, a dedicated surgical suite, and  
17 more than a dozen outpatient clinical services; and

18           WHEREAS, The hospital is staffed by a team of highly  
19 qualified medical professionals, including four primary care  
20 providers who coordinate treatment for patients at all life stages;  
21 referrals can additionally be made to 11 on-site specialists,  
22 providing patients with an exceptional continuum of care at one  
23 location; and

24           WHEREAS, Local residents are further served by the Fountains

1 Assisted Living Facility, situated next to the main hospital  
2 campus, as well as the Wellness Center, the Kittie Nash Groce  
3 Rehabilitation Center, and the Wound Treatment and Hyperbaric  
4 Center; moreover, West Brazos EMS is the only hospital-based  
5 emergency response team in Brazoria County with a medical intensive  
6 care unit, offering security and peace of mind to those in its  
7 service area; and

8 WHEREAS, For half a century, Sweeny Community Hospital has  
9 distinguished itself as a resource of inestimable value to the  
10 region, and members of its skilled and dedicated staff are to be  
11 commended for the difference that they have made in the lives of  
12 countless area Texans; now, therefore, be it

13 RESOLVED, That the House of Representatives of the 84th Texas  
14 Legislature hereby commemorate the 50th anniversary of Sweeny  
15 Community Hospital and extend to all those associated with the  
16 institution sincere best wishes for continued success; and, be it  
17 further

18 RESOLVED, That an official copy of this resolution be  
19 prepared for the hospital as an expression of high regard by the  
20 Texas House of Representatives.
