1 WHEREAS, The citizens of Jacksonville lost an 2 community leader and friend with the passing of Mayor Kenneth 3 Melvin on December 2, 2014, at the age of 74; and WHEREAS, Mr. Melvin was born in Lindale on May 8, 1940, to 4 5 Cosby Ray and Ocie Algerine Melvin; he graduated from Lindale High School and went on to attend Tyler Junior College, The University of 6 7 Texas at Tyler, and Dallas Business School; on May 28, 1959, he married Fredia Nell Glaze, and they shared more than 55 years 8 together while lovingly raising a daughter, Ginger; and 9 WHEREAS, This lifelong Texan started his career as 10 11 assistant manager and manager for various retailers in East Texas; 12 in 1969, he opened his own grocery business, which he sold in 1977 when he began employment with Southwestern Electric Service Company 13 14 in Jacksonville; following 32 years of service, he retired from his position as comptroller of the company's business department; and 15 16 WHEREAS, After completing a training class in Hot Springs, Arkansas, in 1970, Mr. Melvin also enjoyed work as a professional 17 square dance caller; he performed this role at the Jack & Jill Dance 18 Club in Jacksonville and numerous other dance halls around Texas, 19 20 and he was a guest caller for clubs as far away as Canada and Cancún; 21 moreover, he served his peers in a number of offices, including president of the East Texas Callers Association and vice president 22 of the Texas State Callers' Association, and he was the featured 23
