RESOLUTION

- 1 WHEREAS, A life defined by extraordinary strength and
- 2 resilience drew to a close with the death of Walter Kase of Houston
- 3 on March 4, 2015, at the age of 85; and
- 4 WHEREAS, Walter Kase was born Wladyslaw Kasrylewicz on August
- 5 17, 1929, in Lodz, Poland, where his parents, Chaim and Evalina,
- 6 owned a dyeing factory and a commercial laundry; he grew up in a
- 7 happy and loving household enriched by music, shared meals, and the
- 8 celebration of the family's Jewish faith; and
- 9 WHEREAS, This idyllic boyhood was shattered in 1939, when
- 10 Germany invaded Poland; Mr. Kase's family lost their home and all
- 11 their possessions and were forced to live in the ghettos of Lodz and
- 12 Kielce; as the Nazis began their program of extermination, Mr. Kase
- 13 witnessed the murder of his little sister, Rysia, and he and his
- 14 parents were shipped in a packed freight car to the concentration
- 15 camp at Auschwitz-Birkenau; and
- WHEREAS, Mr. Kase's mother was sent to another camp, and he
- 17 and his father kept each other alive throughout the war, first at
- 18 Auschwitz, then in the camps at Pionki, Sosnowiec, Dachau,
- 19 Bergen-Belsen, Mauthausen, and Gunskirchen, where they were
- 20 finally liberated by the United States Army on May 5, 1945;
- 21 Mr. Kase's father died of malnutrition shortly after the war, and,
- 22 all told, 70 members of his family were lost in the Holocaust; only
- 23 Mr. Kase, his mother, and a cousin in Sweden survived; and
- WHEREAS, In 1947, Mr. Kase was one of 400 young Holocaust

- 1 survivors selected by the U.S. Children's Committee to begin a new
- 2 life in America, and he settled in Kansas City, Missouri; equipped
- 3 with a Polish-English dictionary, he taught himself the language
- 4 and worked through high school and junior college together in just
- 5 two years, ultimately landing a sales job with a wholesale costume
- 6 jewelry company; he also met an American girl at the Jewish
- 7 Community Center, and at the age of 20, he married Lila Greenstein;
- 8 around the same time, he was able to bring his mother to the United
- 9 States; and
- 10 WHEREAS, After serving proudly in the U.S. Army in Germany,
- 11 Mr. Kase moved to Houston with his wife, where they were blessed
- 12 with two children, Risha, who was named for his late sister, and
- 13 Kenneth; Mr. Kase resumed his career, expanding the company's
- 14 territory into Texas and Louisiana and becoming one of its most
- 15 successful sales representatives; he also became a silent partner
- 16 in an import company and eventually left his sales job to help run
- 17 the business full-time; he shared the last four decades of his life
- 18 with his second wife, Sylvia Christine Oshman; and
- WHEREAS, After Mr. Kase retired in 1990, he devoted much of
- 20 the next 25 years to speaking to high school audiences about his
- 21 experiences during the Holocaust, and he shared with thousands of
- 22 students his hard-won wisdom about the effects of bigotry and
- 23 prejudice; his efforts earned him the St. Augustine Award from
- 24 St. Thomas University, the Houston Civil Rights Hero Award from the
- 25 Anti-Defamation League, a lifelong honorary membership from the
- 26 national commission of the ADL, and the State of Texas Governor's
- 27 Award for Volunteers, among many others; the ADL's annual Walter

- 1 Kase Teacher Excellence Award and the Walter Kase Commons at
- 2 Hamilton Middle School were named in his honor, and in 2011, he
- 3 received an honorary doctorate from the University of Houston for
- 4 his support of its graduate college of social work; he also served
- 5 on the board of the Houston Holocaust Museum; and
- 6 WHEREAS, Over the course of a remarkable life, Walter Kase
- 7 endured some of the worst cruelties that people can inflict on one
- 8 another, and yet he survived to become a loving father and husband,
- 9 a successful businessman, and a champion for freedom, tolerance,
- 10 and human dignity; now, therefore, be it
- 11 RESOLVED, That the House of Representatives of the 84th Texas
- 12 Legislature hereby pay tribute to the memory of Walter Kase and
- 13 extend sincere condolences to the members of his family: to his
- 14 wife, Sylvia Christine Kase; to his daughter, Risha Dozark, and her
- 15 husband, Patrick; to his son, Kenneth Kase, and his wife, Linda; to
- 16 his grandson, Daniel Dozark; to his stepdaughter, Heidi Massin, and
- 17 her husband, David; to his granddaughter, Kaitlyn Massin; to his
- 18 stepson, Randy Oshman; to his cousins, Sara Mankowitz and her
- 19 husband, Lennart, and Jonny Belchatowski; and to his many friends;
- 20 and, be it further
- 21 RESOLVED, That an official copy of this resolution be
- 22 prepared for his family and that when the Texas House of
- 23 Representatives adjourns this day, it do so in memory of Walter
- 24 Kase.
