1           WHEREAS, The untimely death of Justin Havens Moore on March  
2 30, 2015, at the age of 31, has brought profound sorrow to his  
3 family and friends; and

4           WHEREAS, Born in Stephenville, Justin Moore was the son of  
5 Linda Moore and Robert Paige Moore; he attended Stephenville High  
6 School and participated in 4-H, UIL Number Sense, and soccer, and he  
7 attained the rank of Eagle Scout; after completing his bachelor's  
8 degree in industrial distribution at Texas A&M University, he  
9 joined the staff of Applied Technologies of Atlanta, Georgia, where  
10 he was a member of the leadership development program for inside  
11 sales in industrial manufacturing; and

12           WHEREAS, Mr. Moore suffered from severe congenital heart  
13 disease, and when his health worsened in 2008, he moved home to  
14 Texas to be closer to his family; he worked as the territory manager  
15 for NSK Applied Industrial Technologies, handling sales in Texas,  
16 Kansas, Louisiana, and Oklahoma, before serving as a regional sales  
17 manager for WJB Group; and

18           WHEREAS, In 2010, Mr. Moore became the proud father of a  
19 daughter, Averie Marie Moore; he was devoted to his "shining star,"  
20 and he especially loved taking her to the park and teaching her how  
21 to fish; an avid traveler, he visited his sister during her  
22 residence in England, and he took trips to France and Spain; he was  
23 an excellent cook and enjoyed watching the Food Network and trying  
24 out new recipes; in addition, he was a loyal fan of the Dallas

1 Cowboys and Texas A&M football, and he delighted in debating with  
2 his mom and helping his relatives with technology; he was very fond  
3 of his golden retriever, Toby; and

4 WHEREAS, Justin Moore faced the difficult challenges of his  
5 illness with enormous grace, courage, and determination, and  
6 although he is deeply missed, his loved ones will forever cherish  
7 their memories of his wry wit and his kind and caring ways; now,  
8 therefore, be it

9 RESOLVED, That the House of Representatives of the 84th Texas  
10 Legislature hereby pay tribute to the life of Justin Havens Moore  
11 and extend sincere condolences to the members of his family: to his  
12 parents, Paige and Linda Moore; to his sister, Maren Moxom and her  
13 husband, Nathaniel; to his daughter, Averie, and her mother, Jayme  
14 Wright; to his nephew, Raleigh Moxom; and to his other relatives and
