1           WHEREAS, Citizens from across the Lone Star State are  
2 gathering at the State Capitol on May 4, 2015, for the Peace  
3 Officers' Memorial Ceremony, held in honor of those brave men and  
4 women who have lost their lives in the line of duty; and

5           WHEREAS, Texans everywhere are indebted to members of the law  
6 enforcement profession who, by their selfless devotion to the  
7 public welfare, have enabled us to enjoy the benefits of a peaceful  
8 and orderly society; and

9           WHEREAS, Too seldom recognized and sometimes taken for  
10 granted by the public they so faithfully serve, these intrepid  
11 individuals daily risk their lives in order to preserve domestic  
12 tranquility and to protect their fellow residents; and

13           WHEREAS, Deputy Sheriff Adam J. Davis of the Bell County  
14 Sheriff's Office earned the respect and admiration of his peers for  
15 his commitment to serving the greater good, and his contributions  
16 will not soon be forgotten; and

17           WHEREAS, Throughout his tenure, which spanned 10 years and 10  
18 months, Deputy Sheriff Davis demonstrated the loyalty, courage, and  
19 self-sacrifice that are consistent with the highest ideals of the  
20 law enforcement profession; and

21           WHEREAS, Killed in the line of duty on Wednesday, December  
22 11, 2013, at the age of 36, Deputy Sheriff Davis will long be missed  
23 by his family, his fellow peace officers, and the entire community;

1           WHEREAS, Though his life ended far too soon, Deputy Sheriff  
2 Davis left behind a notable legacy that will forever be honored by  
3 those who follow in this difficult but essential profession; now,  
4 therefore, be it

5           RESOLVED, That the House of Representatives of the 84th Texas  
6 Legislature hereby pay tribute to the life of Deputy Sheriff Adam J.  
7 Davis of the Bell County Sheriff's Office and extend deepest  
8 sympathy to his relatives, friends, and fellow officers; and, be it
