WHEREAS, Texas Agricultural Lifetime Leadership, or TALL, is 4 a program of the Texas A&M AgriLife Extension Service that seeks to 5 prepare men and women for challenging careers in agriculture; 6 Mr. Hill, a founding member of TALL, has given generously of his 7 time and resources to the program since its establishment in 1987; 8 he has continuously served on the program's advisory board and has 9 further lent his expertise to the TALL cohort selection committee; 10 11 and

12 WHEREAS, A native of Sulphur Springs who served as president of the Texas FFA, Marcus Hill graduated from Texas A&M University in 13 14 1971 with a bachelor's degree in agricultural education and worked toward a master's degree in educational psychology; he began 15 selling insurance with National Farm Life during college, and after 16 his graduation, he was hired full-time by the business and its 17 subsidiary, Agricultural Workers Mutual Auto Insurance Company; 18 and 19

20 WHEREAS, Mr. Hill went on to accept increasing levels of 21 responsibility in Ag Workers, including appointment as its 22 president in 1988 and as chair of its board of directors in 2006; 23 and

24 WHEREAS, Deeply committed to Texas agriculture and to youth

who aspire to careers in the field, Mr. Hill serves on the Texas 4-H Youth Development Foundation Board and chairs the Youth Educational Activities Committee at the State Fair of Texas; he is a director of the Fort Worth Stock Show and Rodeo, and he frequently attends local stock shows and fairs to support young competitors; in addition, he is a former member of the Texas FFA Foundation and has served as chair of the Attorney General's Youth Conference; and

8 WHEREAS, This dynamic Texan's experience includes membership on the College of Agriculture Development Council at Texas A&M, the 9 10 Chancellor's Council at Texas Tech University, and the Dean's Advisory Council for the College of Agricultural and Environmental 11 12 Sciences at Tarleton State University; he has served as chair of the 13 Tarrant County Program Building Committee and as a member of the 14 Farm and Ranch Club of the Fort Worth Chamber of Commerce and the 15 Texas and Southwestern Cattle Raisers Association, to name but a few of the organizations that have benefited from his involvement; 16 17 and
