- 1 WHEREAS, The life of an admired civic leader drew to a close
- 2 with the passing of Earl Charles Lairson of Houston on April 2,
- 3 2015, at the age of 87; and
- WHEREAS, Born and raised on a farm in Pottawatomie County,
- 5 Oklahoma, Mr. Lairson graduated from Tecumseh High School as
- 6 valedictorian of his class; he joined the United States Army at the
- 7 age of 17, as World War II was drawing to a close, and he
- 8 subsequently served for two years in the Oklahoma Air National
- 9 Guard; while completing his bachelor's degree in accounting at the
- 10 University of Oklahoma, he enrolled in ROTC, and he achieved the
- 11 rank of first lieutenant in the U.S. Army Reserve; and
- WHEREAS, Mr. Lairson settled in Houston and was employed by
- 13 Ernst & Ernst; in 1970, he founded his own CPA firm, Earl Lairson
- 14 and Company, which became Null-Lairson following a merger in 1997;
- 15 dedicated to the advancement of his profession, he was a charter
- 16 member of the National Conference of CPA Practitioners, and he
- 17 served on its board and as president of its Houston Chapter; he was
- 18 also a founding member of the Texas Association of CPAs, and during
- 19 two terms on the Texas State Board of Public Accountancy, he served
- 20 for a year as chair; moreover, he was a life member of many CPA
- 21 organizations, among them the American Institute of CPAs and the
- 22 Texas Society of CPAs; and
- WHEREAS, Active in the Republican Party from 1960 onward,
- 24 Mr. Lairson worked on the Draft Goldwater campaign and on the first

- 1 congressional campaign of George H. W. Bush; he served as a precinct
- 2 chair for 35 years and as a member of the Texas State Republican
- 3 Executive Committee for a decade; and
- WHEREAS, Mr. Lairson further benefited his community through
- 5 his involvement in numerous organizations; he was a director of the
- 6 Houston Club and chair of its finance committee, and he was a
- 7 charter member of the Greater Heights Chamber of Commerce and of the
- 8 Greater Houston Pachyderm Club; the founding president of the
- 9 Pachyderm Club of Northwest Houston, he received the group's Tough
- 10 Tusk Award; for many years, he served as president and program chair
- 11 of the Northwest Executive Round Table, and he was a charter member
- 12 and vice president of the Magic Circle Exchange Club of Houston; he
- 13 was also a trustee of the Educational Advancement Foundation and a
- 14 longtime advisory board member and accountant for the Free
- 15 Enterprise Institute; and
- WHEREAS, Deeply committed to serving others, Mr. Lairson was
- 17 a life member of the American Legion and an endowed member of the
- 18 Oak Forest Masonic Lodge No. 1398, and he belonged to Arabia Temple
- 19 Shriners, Tranquility Lodge 2000, the Sam Houston Hall of Fame,
- 20 Ruthven Commandery No. 2, the Washington Chapter of Royal Arch
- 21 Masons, and Houston Council No. 1; he was an active member of First
- 22 Methodist Church of Houston as well, and he served as a Sunday
- 23 school teacher and as a member of the administrative board and the
- 24 finance and audit committees; in 2008, he joined Candlelight Church
- 25 of Christ, which he served as a trustee; and
- 26 WHEREAS, Above all, Mr. Lairson was devoted to his wife,
- 27 Virginia, with whom he shared 63 years, and their cherished family;
