## RESOLUTION

1 WHEREAS, The Honorable Wayne A. Brascom completed his 2 distinguished tenure as Llano County judge in December 2014; and 3 WHEREAS, First elected in 2006, Judge Brascom worked tirelessly to improve the quality of life available to area 4 5 residents; he negotiated the transition from the Llano County Hospital Authority to the Scott and White Hospital System, and he 6 7 also assisted in obtaining medical services for citizens through a new healthcare waiver; and 8

9 WHEREAS, This dynamic Texan enhanced the efficiency of the 10 probate court, and he worked with the county attorney's office to 11 develop a bond forfeiture program; in accordance with House Bill 12 1117, passed by the 78th Texas Legislature, he worked with the 13 commissioners court to implement an official road map legally 14 establishing the roads the county will continue to maintain as 15 public thoroughfares; and

WHEREAS, Committed to meeting the needs of local youth as 16 well, Judge Brascom served for eight years on the Llano County 17 Juvenile Probation Board, and he obtained a new classroom building 18 from the Llano Independent School District for the Head Start 19 Program in Kingsland; moreover, he procured computers for the 20 21 sheriff's office by means of a grant from the governor's office, and he assisted in arranging funds for the Llano Special Opportunity 22 23 Recycle Center; and

citizens in many other leadership roles; he has served the 1 executive board of the Capital Area Council of Governments as 2 chair, vice chair, and secretary, and he was a member of the 3 Corporation of Texas Regionalism, a statewide board that reviews 4 5 legislative priorities for Councils of Government; in addition, he served a term as vice chair during his eight years on the Hill 6 Country Mental Health and Developmental Disabilities Board, and he 7 8 was appointed by the governor to participate in the review and revision of the Health and Safety Code regarding mental health 9 10 issues; and

11 WHEREAS, Through his significant accomplishments in office, 12 Wayne Brascom helped to make Llano County an even better place in 13 which to live, and he may take justifiable pride in his 14 contributions; now, therefore, be it

15 RESOLVED, That the House of Representatives of the 84th Texas 16 Legislature hereby honor Judge Wayne Brascom for his exemplary 17 service as Llano County judge and extend to him sincere best wishes 18 for the future; and, be it further

19 RESOLVED, That an official copy of this resolution be 20 prepared for Judge Brascom as an expression of high regard by the 21 Texas House of Representatives.
