1 WHEREAS, Dr. Ervin D. Seamster Jr., senior pastor at Light of 2 the World Church of Christ in Dallas, is serving as Pastor of the 3 Day for the Texas House of Representatives on April 29, 2015; and WHEREAS, Ervin Seamster earned a bachelor's degree from 4 Southwestern Christian College and a master of divinity degree from 5

WHEREAS, Accepting the call to ministry in 1985, Dr. Seamster preached his first sermon the following year; he went on to serve as 10 11 minister of the Marsalis Avenue Church of Christ in Dallas, and in 1999, he founded the Light of the World Church of Christ; over the course of his tenure as senior pastor, he has overseen a dramatic 13 14 growth of the congregation and the development of nearly 25 ministries; and

15 WHEREAS, Dr. Seamster has further distinguished himself 16 through his notable career in academia; he joined the faculty of 17 Abilene Christian University in 1999 and taught courses in Old 18 Testament theology and urban ministry in the 21st century for 19 20 several years; moreover, he earned the distinction of becoming the 21 first African American to be appointed as special assistant to the school's president, and in that position, he recruited gifted 22 23 scholars of color for the doctoral fellows program for minority 24 faculty members; in addition, he is a cofounder of Northwest

- 1 Preparatory School in Houston, and he has served that institution
- 2 as board president and as president emeritus; he has also given
- 3 generously of his time and talents in behalf of Southwestern
- 4 Christian College, raising funds for the school through the Fab
- 5 Five Revival and uniting ministries across the nation through the
- 6 One in Christ Conference; and
