1 WHEREAS, The doctors and staff at Rodeo Dental and
2 Orthodontics have distinguished themselves by providing pro bono
3 treatment to many uninsured youths, and the clinic's efforts in
4 their behalf are truly deserving of special recognition; and

5 WHEREAS, Following a crisis in orthodontic care for Texas
6 Medicaid patients in 2011, thousands of young people who had begun
7 orthodontic treatment were left in limbo, without an orthodontist
8 to continue their care; and

9 WHEREAS, Led by Drs. Brian Dugoni, Saam Zarrabi, and Yahya
10 Mansour, Rodeo Dental and Orthodontics has since provided services
11 to some 1,262 youngsters at clinics in Fort Worth and in the Rio
12 Grande Valley, and the value of their charitable endeavors is
13 incalculable; and

14 WHEREAS, By volunteering their time and expertise to complete
15 the orthodontic work begun on many young patients, the doctors and
16 staff of Rodeo Dental and Orthodontics have set an inspiring
17 example of generosity and have honored the highest ideals of their
18 profession; now, therefore, be it

20 Legislature hereby commend Rodeo Dental and Orthodontics for
21 delivering pro bono treatment to uninsured youths and extend to the
