- 2 judicial commission on April 22, 2015, to serve as a United States
- 3 district judge of the U.S. District Court, Southern District of
- 4 Texas; and
- 5 WHEREAS, Nominated for the post by President Barack Obama,
- 6 Judge Hanks was confirmed by the U.S. Senate by a unanimous vote on
- 7 April 20; and
- 8 WHEREAS, Judge Hanks is a native of Breaux Bridge, Louisiana,
- 9 and graduated with his bachelor's degree, summa cum laude, from
- 10 Louisiana State University in 1986; he went on to attain his juris
- 11 doctorate from Harvard Law School in 1989 and recently furthered
- 12 his education with his receipt of a master of laws degree in 2014
- 13 from the Duke University School of Law; and
- 14 WHEREAS, After beginning his career as a law clerk under the
- 15 Honorable Sim Lake of the U.S. District Court, Southern District of
- 16 Texas, George Hanks served as an associate at the law firm of
- 17 Fulbright & Jaworski from 1991 to 1996 and as a shareholder at
- 18 Wickliff & Hall, PC, from 1996 to 2000; from 2001 to 2002, he served
- 19 as district judge for the 157th Civil District Court of Texas, and
- 20 from 2003 to 2010, he served as a justice on the First Court of
- 21 Appeals of Texas; in September 2010, he became a U.S. magistrate
- 22 judge in the Southern District; and
- 23 WHEREAS, A member of the American Law Institute, Judge Hanks
- 24 has worked as an adjunct professor at the University of Houston Law

- 1 Center and as a faculty member of the National Judicial College and
- 2 National Institute for Trial Advocacy; in addition, he has authored
- 3 legal publications and lectured at continuing education seminars
- 4 around the country; he has served on the State Bar Committee on
- 5 Pattern Jury Charges and on the Texas Judicial Panel for
- 6 Multi-District Litigation, as well as on the board of directors of
- 7 the Judicial Section of the State Bar of Texas; and
- 8 WHEREAS, This prominent jurist is admitted to the Texas and
- 9 District of Columbia bars, and he holds memberships in the College
- 10 of the State Bar of Texas, the Houston Lawyers Association, and
- 11 numerous bar associations; moreover, he is a former special
- 12 disciplinary counsel for the Texas State Bar Commission for Lawyer
- 13 Discipline as well as a former chair and member of the District 4F
- 14 State Bar Grievance Committee in Houston; he has also volunteered
- 15 his time with a range of community organizations that include the
- 16 American Red Cross and Big Brothers Big Sisters of Houston; and
- 17 WHEREAS, Throughout his career, Judge Hanks has demonstrated
- 18 an unwavering commitment to the highest standards of public
- 19 service, and he may indeed reflect with pride on his achievements as
- 20 he takes on his challenging new role; now, therefore, be it
- 21 RESOLVED, That the House of Representatives of the 84th Texas
- 22 Legislature hereby congratulate the Honorable George Carol Hanks
- 23 Jr. on his appointment as a U.S. district judge for the Southern
- 24 District of Texas and extend to him sincere best wishes for a
