1 WHEREAS, Those Texans who give freely of their time and
2 talents to benefit their fellow citizens make the world a better
3 place through their actions and their example, and Dr. Charles Ku
4 is being recognized for his exceptional community service by being
5 named a recipient of a 2015 Profiles in Leadership Award; and

6 WHEREAS, A practicing dentist in Lewisville since 1974,
7 Dr. Ku has demonstrated his commitment to the Dallas-Fort Worth
8 area through his involvement in a wide variety of organizations,
9 from the Dallas Red Cross to the Asian Chamber of Commerce to the
10 Richardson Independent School District; he currently holds
11 membership in the Lewisville Noon Rotary Club, the Super Bowl XLV
12 Host Committee, the University of North Texas College of Arts and
13 Sciences Advisory Board, the Dallas Baptist University Board of
14 Trustees, the World Affairs Council of DFW Board of Directors, the
15 Taiwanese Chamber of Commerce of DFW Board of Directors, and the
16 Dallas-Taipei Sister City Committee, of which he is chair; and

17 WHEREAS, Dr. Ku has founded Chinese language and culture
18 schools as well as a retirement community and an adult day care
19 center in the area, and he serves as a deacon at First Baptist
20 Church of Lewisville; furthermore, he has been appointed to the
21 State Board of Dental Examiners, the Federal Commission on
22 Apprenticeship, and the Statewide Health Coordinating Council, and
23 the president of Taiwan has named him an overseas Chinese
24 commissioner; and

2 the devoted efforts of individuals such as Charles Ku, whose
3 tireless work has contributed immeasurably to the quality of life
4 in the Dallas-Fort Worth Metroplex; now, therefore, be it
