- 15 of the political science department at The University of Texas--Pan
- 16 American, where over the past four decades he has taught a variety
- 17 of courses in the politics of Latin America; he has also served the

- 19 UTPA faculty senate and the university's Publications Board,
- 20 Library Committee, Latin American Studies Committee, and
- 21 International Committee; additionally, he was a visiting professor
- 22 at Universidad de las Americas in Cholula, Mexico, from 1979 to
- 23 1981; and
- 24 WHEREAS, This respected educator is a member of the Latin

- 1 American Studies Association, the Southwest Conference of Latin
- 2 American Studies, the Western Social Science Association, and the
- 3 Western Political Science Association, and he is the author of many
- 4 academic articles and papers, as well as a book, After Santo
- 5 Domingo, What?; and
- 6 WHEREAS, Dr. Mounce's erudition, expertise, and dedication
- 7 have greatly benefited his students and The University of
- 8 Texas--Pan American; he has earned the respect and admiration of
- 9 his colleagues, and he may indeed take great pride in his notable
