- 9 WHEREAS, Nationally recognized for its efforts, Mosquito
- 10 Control was the first group to document the existence of the Asian
- 11 tiger mosquito in the continental United States, a discovery it
- 12 made in 1985; the division employs sophisticated research methods
- 13 and technologies to prevent and control a wide array of ailments
- 14 spread by mosquitos, such as West Nile virus, St. Louis
- 15 encephalitis, dengue fever, and chikungunya; moreover, the unit has
- 16 partnered with a number of entities, including universities, the
- 17 Houston Museum of Natural Science, and the Centers for Disease
- 18 Control and Prevention, to find effective ways to deal with
- 19 mosquito-borne diseases and the risks they pose to public health;

- 22 has contributed significantly to protecting the health and
- 23 well-being of Harris County residents, and it is indeed fitting
- 24 that the division's staff be commended on their outstanding work;
