- 2 a degree from Arlington State College, now The University of Texas
- 3 at Arlington; since 1963, he has served as president of PICS
- 4 Investment Company, and since 1978, he has also been a managing
- 5 partner of K-B Oil Company; in addition, he has worked as an agent
- 6 and broker for Ebby Halliday Realtors since 1995; in all his
- 7 endeavors, he has benefited from the love and support of his wife of
- 8 40 years, Deborah, and his 7 children and 16 grandchildren; and
- 9 WHEREAS, Each day, public servants improve the quality of
- 10 life for their fellow citizens in innumerable ways, and the efforts
- 11 of Sheffie Kadane have helped to make the city he loves an even
- 12 better place in which to live and work; now, therefore, be it
