6 which is also known as The University of Texas at San Antonio

9 for Law and Public Affairs; the initiative gives students who have  
10 an interest in public policy the opportunity to work as interns at  
11 the State Capitol during legislative sessions; and

12           WHEREAS, A senior at UTSA, Ms. Parkey expects to receive her  
13 bachelor's degree in history and legal studies in May 2015; she  
14 received a full-ride undergraduate scholarship as a Terry  
15 Foundation Scholar, and she served a semester-long internship at  
16 the Holocaust Museum in Washington, D.C., as a Bill Archer Fellow;  
17 she has also served as a justice in the Student Government  
18 Association, and she was the family relations director of the For  
19 the Kids Dance Marathon, helping to raise more than \$50,000 for  
20 charity; and

21           WHEREAS, While gaining important experience in the field of  
22 public service as a member of Speaker Straus's staff, Katrina  
23 Parkey has contributed to the workings of state government  
24 firsthand and learned more about the legislative process and the
