3 Elbanna is a participant in the UT-Dallas Legislative Internship
4 Program and has served as a staffer for the House Committee on
5 Economic & Small Business Development; she expects to graduate with
6 her degree in political science in the spring of 2016 and intends to
7 pursue a career in the realm of law and public service; and

8 WHEREAS, A freshman in the School of Public Affairs at UT,
9 Daniel Khalil is the son of Ali Khalil and Rosemarie Heusinger; he
10 plans to eventually specialize in social and economic policy, to
11 earn his master's degree, and to work either in Texas or in
12 Washington, D.C.; and

13 WHEREAS, Antoinette Mays is an alumna of St. Mary's
14 University School of Law and the daughter of Angela and Herman
15 Baxter; she joined the staff as a participant in the Energy and
16 Environmental Law Internship Program, with her responsibilities
17 encompassing research into those topics, and she hopes to find
18 employment with an energy company and specialize in regulatory and
19 compliance issues; and

20 WHEREAS, The son of Mallerick and Loretta Warnell, Mallerick
21 "Rick" Warnell II is taking part in the Texas Legislative
22 Internship Program; he is currently a senior at Lamar University,
23 where he is working toward a bachelor's degree in psychology; and

25 their duties as legislative interns with great skill and diligence,
26 and they are indeed deserving of special recognition for their fine
27 work; now, therefore, be it
